A motion by Gary E. Truckenmiller, seconded by Lance K. Gresh and passed to provide benefits for full-time employees as follows:

- 1. 10 vacation days/5 days may be carried over year to year
- 2. 2 vacation days/ 5 years of service, maximum of 10
- 3. 10 sick days/40 days may be carried over year to year
- 4. 4 personal days
- 5. 3 days bereavement for immediate family
- 6. 12 holidays
- 7. Pension Plan at 13% of yearly compensation
- 8. Insurance/Medical Insurance
- 9. Health/Accident/Life Insurance
- 10. Jury Duty Pay with 15-day cap

A motion by David R. Smith, seconded by Gary E. Truckenmiller and passed to set the wages for the Secretary/Treasurer and Full-Time employees as \$25.50 per hour.

A motion by Gary E. Truckenmiller, seconded by Lance K. Gresh and passed to set the part-time employee wages at \$18.00 - \$25.00 per hour depending on need and skills required for Robert Foresman and Kyle Powers.

A motion by Lance K. Gresh, seconded by David R. Smith and passed to set the part-time wages of Douglas Ertel and Jon McCormick at \$25.50 per hour with holiday pay if working during the pay period of a holiday.

A motion by Gary E. Truckenmiller, seconded by David R. and passed to join PSATS; Northumberland County Association, PSATS drug/alcohol program; L3P; and Central PA Chamber of Commerce.

A motion by Lance K. Gresh, seconded by David R. Smith and passed to purchase the Township News for elected and appointed officials.

A motion by Gary E. Truckenmiller, seconded by Lance K. Gresh and passed to delegate the Supervisors and Secretary to the State Convention.

A motion by Lance K. Gresh, seconded by David R. Smith and passed to reimburse \$0.70 per mile for use of personal vehicle.

A motion by Gary E. Truckenmiller, seconded by David R. Smith and passed to advertise meetings for the first Monday of each month at 6:30 P.M. at the Delaware Township Building except for May 12, second Monday and September 2, first Tuesday.

A motion by Lance K. Gresh, seconded by Gary E. Truckenmiller and passed that in an emergency with the agreement of two (2) Supervisors, purchase or repairs of equipment and supplies may be made up to \$23,800, but over \$12,900 must consult all three (3) Supervisors.

A motion by Lance K. Gresh, seconded by Gary E. Truckenmiller and passed with one abstention, (Smith), to hire David R. Smith as an equipment operator.

A motion by Gary E. Truckenmiller, seconded by David R. Smith and passed with one abstention, (Gresh), to hire Lance K. Gresh as an equipment operator.

A motion by Lance K. Gresh, seconded by David R. Smith and passed to with one abstention, (Truckenmiller), to hire Gary E. Truckenmiller as an equipment operator.

A motion by Gary E. Truckenmiller, seconded by David R. Smith and passed to hire Lance K. Gresh and David R. Smith as Co-Roadmasters.

A motion by Gary E. Truckenmiller, seconded by Lance K. Gresh and passed to approve the written report for the Penn Great Dane Solar LLC Conditional Use Hearing with changes that were discussed.

A motion by Gary E. Truckenmiller, seconded by David R. Smith and passed to adopt the Zoning Ordinance Amendment 2025-0101.

A motion by Lance K. Gresh, seconded by David R. Smith and passed to pay the bills as presented.

A motion by David R. Smith, seconded by Lance K. Gresh and passed to adjourn the meeting. The meeting was adjourned at 5:55 P.M.
